The City of Anthony, New Mexico (the “City”) hereby gives notice of a regular meeting of the Board of Trustees (the “Board”) of the City on January 3, 2024, at the hour of 6:00 p.m. at Court Chambers, 820 Highway 478, Anthony, NM 88021. At such meeting, or as soon thereafter as the matter may be heard, the Board, constituting the governing body of the City, will hold a public hearing concerning, and will consider for adoption an ordinance (the “Ordinance”) relating to the City’s proposed Taxable Industrial Revenue Bonds (Hota Project), Series 2024. AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF CITY OF ANTHONY, NEW MEXICO TAXABLE INDUSTRIAL REVENUE BONDS, IN ONE OR MORE SERIES, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$100,000,000 TO FINANCE THE ACQUISITION OF ALL LAND, EASEMENTS AND OTHER PROPERTY RIGHTS, AND THE ACQUISITION, CONSTRUCTION, RENOVATION, REFURBISHMENT, EQUIPPING AND INSTALLATION OF ALL NECESSARY AND USEFUL CAPITAL EQUIPMENT AND OTHER TANGIBLE PERSONAL PROPERTY FOR THE CONSTRUCTION OF A POWERTRAIN FOR EV COMPONENT MANUFACTURING FACILITY (THE “PROJECT”) FOR USE BY A SUBSIDIARY OF HOTA INDUSTRIAL MFG. CO LTD (TOGETHER WITH ITS SUCCESSORS, ASSIGNS, SUBSIDIARIES AND AFFILIATES, THE “COMPANY”); AUTHORIZING THE EXECUTION AND DELIVERY OF AN INDENTURE, A LEASE AGREEMENT, A BOND PURCHASE AGREEMENT, THE BONDS AND OTHER DOCUMENTS IN CONNECTION WITH THE ISSUANCE OF THE BONDS AND THE PROJECT; MAKING CERTAIN DETERMINATIONS AND FINDINGS RELATING TO THE BONDS AND THE PROJECT; RATIFYING CERTAIN ACTIONS TAKEN PREVIOUSLY AND REPEALING ALL ACTIONS INCONSISTENT WITH THIS ORDINANCE.
