a. An update on the City Attorney Contractual Services Request for Bids, **Presented by CPO**. The Chief of Procurement Officer explained that the deadline was set for May 24th, to which no offers were made. The current city attorney turned in his 30 days of notice to terminate his contract, making June 22nd his last day contracted with the City of Anthony. The bid was posted for two consecutive Sundays on the Las Cruces Sun News as well as the city website. This new policy will start the process of transitioning the current digitalized timecard system, which tracks GPS location and Clocking in and out, to a paper-based version. ### 11. ITEMS FROM THE MAYOR AND TRUSTEES

**Trustee Herrera:** requested lighting be placed at the Little Adams Park basketball court. He also requested an update from El Paso Electric regarding lighting issues he brought to the board's attention in previous meetings. Trustee Herrera also informed Mayor that there is no lighting at Duffer Lane, and requested a light be placed on Polk and Lee. He also requested to have a joint meeting or presentation done with the Parks Commission to go over any projects done or potential projects. Lastly, he requested that the board rescind Ordinance 2019-002 which provides the hiring of a City Manager.

**Trustee Barreras:** requested an update on properties on Church Street and Charles which was brought to the board's attention in previous meetings.

**Trustee Garcia:** had several residents call because they could not gain access to their property due to roads being unpaved. The Parks and Recreation Manager explained that Marrow is relocating the water meters and would repave the streets as they finish their projects. Trustee Garcia requested that Public Works replace and add street names as needed in the city.

MPT Holguin: agreed with Trustee Herrera regarding rescinding the City Manager Ordinance, as well as meeting with the Parks Commission and other committees to build open communication. MPT Holguin also thanked Trustee Garcia for providing the Timecard Policy. MPT Holguin explained he has received pushback throughout his term, and believes it is time for change. He also reminded the residents that the Elections for Mayor opens next November. MPT Holguin made a motion to add the first hearing for City Manager Ordinance, and the presentation for the Parks and Recs Commission for the upcoming meeting.
