The Projects Coordinator informed the board about the ICIP that could potentially be passed by the next meeting was open to amendments and changes at the discretion of the board so that they may be presented to Senior Planner Tiffany Goolsby. The ICIP is a document that is passed on a yearly basis, but is within a four-year range. This document is used to apply for grants; therefore, any amendments are appreciated before the next meeting. The board suggested the first 5 items be rearranged by priority.

Chief of Police explained the potential collaboration between the City of Anthony New Mexico Police Department and the New Mexico State University Police Department regarding working special projects at NMSU at a rate of pay of \$65 an hour to no expense of the city. This agreement has been reviewed by legal attorneys for both parties involved. The trustees questioned if this agreement would conflict with the needs

of the city. Chief Ordonez assured the board that the officers cannot be scheduled to work for the city while working the events at NMSU. This is strictly while they are off duty. If for any given reason the officer's assistance is needed while assisting at NMSU, the City of Anthony will take priority. Trustee Herrera asked about the process if for any given reason a lawsuit or Tort Claim is involved, which chief of police responded she would get a response from the attorney.

10. ITEMS FROM THE MAYOR AND TRUSTEES

Trustee Herrera: none

Trustee Garcia: Trustee Garcia has several concerns that will be listed below.

- Trustee Garcia had a question regarding the Adams Ball Park watering schedule. The Parks and Recreation Manager answered that it is on a watering schedule starting at 12 am and ends at 5 am daily by an automatic sprinkler. He also noted that any visible patches are being treated by public works. Trustee Garcia also asked how often the field is dragged. The Parks and Recreation Manager noted that the city does not own a drag, but is something that will be purchased soon. Once that is ordered, public works will be able to attend to dragging the field for use.
- Trustee Garcia requested information on the **Concession Stand**. He was informed that a PO was just sent requesting a schedule. A meeting is scheduled regarding that manner, and a schedule will be sent to the board. A time frame of approximately 49 working days was given, but that would be better determined with time.
- Trustee Garcia asked what options the city can take for the **removal of dried trees at Dos Lagos**. Burning the trees with the help of the Fire Department is an option, however, would result in a massive fire that may take days to put out. The second option would be to rent out a shredding bin to downsize the trees, which would create mulch that could be used by the residents and local nurseys. The last suggestions were working with a company through El Paso Electric or a mixture of burning and shredding the trees to the discretion of the board. Trustee Herrera mentioned that South Central Waste Authority has a woodchipper, which could also be a potential option.
- Trustee Garcia requested the number of **salaried employees**, hourly paid employees, and **remote workers**. He also requested to know why employees have the option to work remotely.
- Lastly, he asked for the method of clocking in. City employees can manually clock in through a laptop or phone.
 Trustee Garcia was advised to take this request to administration for operational purposes. Trustee Garcia made a motion to add Consideration and Action for a Resolution changing the clock in method, to one that requires the physical presence of the employee apart from the Police Department.
