#### 7. PRESENTATION

a. Presentation on the Financial Reports for November 2024, Presented by the Finance Director.

4-0 Vote, Motion Passes.

The Finance Director provided a brief presentation on the current financial reports. As of November 30th, the city has received approximately \$1.8 million in revenues out of the projected \$4.8 million. For most departments, expenditure remains below the anticipated projections. Truste Herrera also requested a list of all employees on provisional pay, be sent to all trustees via email, to which administration concurred. Trustee Herrera inquired about the source of funds for provisional/temporary pay administered to staff members taking on additional duties. The Finance Director explained that while this is not a specific line item, it is included within the projected payroll. The Finance Director stated that he will be sending out a report that highlights the total amount being paid in provisional/temp for each individual. Total expenses to date are \$1.7 million, resulting in a surplus of \$131,588.17. There was discussion regarding the potential change of the Parks and Facilities Department into the anticipated Community Development Department. The Finance Director assured the Board that this change is feasible and provided information on the total budget available to support the transition.

#### 8. CONSIDERATION AND ACTION

**a.** Consideration and action to approve a tenant for Suite B located at 780 Landers Rd., **Presented by the City Clerk.** 

The City Clerk informed the Board of a recent vacancy in one of the portables and noted that two parties, Tresco and Community Action, had expressed interest in the newly available space. She explained that Tresco, already occupying part of the building, would expand into the vacant area if selected, whereas Community Action leases the majority of the area. Michael Armendariz with Tresco provided a brief presentation outlining the services they offer to the community and emphasizing their need for additional space. After hearing about Tresco's specific need for expansion, Community Action graciously withdrew their interest in the space, thereby allowing Tresco to occupy the vacant area. Motion was made to approve Tresco as the tenant for the remaining space of Suite B located at 780 Landers Rd.

**b.** Consideration and Action to approve the lease agreement between Las Cruces Physicians Practices, LLC and the City of Anthony, *Presented by the HR/CPO*.

The draft lease agreement was presented with revisions already made by the attorney. MPT Holguin requested that the City Attorney review some of the more significant revisions and highlight any potential concerns. Clarification was provided regarding the expected move-in date for the tenant, which is currently anticipated to be April 2025. MPT Holguin inquired about the basis for the rent amount. In response, HR/CPO explained that a broker conducted a study of comparable properties in the surrounding area, considering the size of the building. After negotiations, the rent was set at \$24 per square foot with a 3% increase per year.

c. Consideration and Action to award the On-Call Engineering Services, Presented by HR/CPO.

As a result of the RFP issued for On-Call Engineering Services, four proposals were received. Following evaluations by a panel of five reviewers, Bohannan Huston is recommended based on the scoring results. MPT Holguin noted that this was a necessary step. Mayor Murillo clarified that the City will continue working with Wilson & Co. on projects they are contractually obligated to complete. MPT Holguin suggested all projects be looked over by legal counsel to get recommendations on whether Wilson & Co. or Bohannan Huston should continue the work and assistance with City administration and new projects will be awarded to Bohannon Huston concurrence was obtained by the governing body and administration.
